



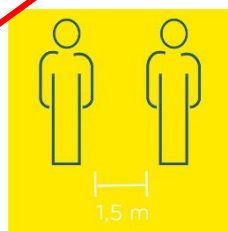

We care about your health

Since the health of our guests and employees is very important to us, we have developed extensive hygiene measures on the basis of the currently applicable legal requirements in Germany. An effective concept presupposes that all parties involved deal responsibly with the current situation. Organizers, guests and staff must work closely together to minimize potential risks and ensure a safe stay.

Therefore, we have deliberately decided to only welcome guests according to the **3G-rules** - German expression for **vaccinated** (*geimpft*), **recovered** (*genesen*) **or tested** (*getestet*) - and to maintain the very high hygiene standards. The same rules apply to all of the hotel employees as well.

Our hygiene concept was developed in coordination with the Pandemic Committee of Commerzbank AG and the responsible health authority and is constantly updated according to the latest specifications and developments.

We are very pleased to continue to offer you a safe and relaxed atmosphere for your events, meetings and stays with us.

Here have listed the general rules of conduct for you:

- At check-in, guests must provide **negative proof** (3G). This is controlled by the employees of the Collegium. Please see details below.
- **Mask obligation:** Within the Collegium Glashütten there is an obligation to wear a medical mask (surgical or FFP2 mask) in all public areas. These include the lobby, the bar, the corridors as well as the restaurant.
- **Minimum distance:** The minimum distance of 1.50 m between the individual persons of different events applies in the public areas of the Collegium.
- **Maintain sneezing and coughing etiquette**
- **Regular hand washing and disinfection**
- **Regular ventilation of all rooms**
- **Contact tracing:** Our hotel and day guests are automatically registered at check-in. The data will be stored temporarily in accordance with the applicable data protection regulations.

The following is considered negative evidence under the 3G regulation:

- **Proof of vaccination:** Proof of vaccination is proof of the existence of a complete vaccination against the coronavirus SARS-CoV-2 in analogue or digital form, e.B. presentation of the vaccination certificate or via the CovPass
- **Proof of recovery:** Proof of recovery is the presentation of a medical or official certificate of a previous infection with Covid in analogue or digital form. The underlying test must have been carried out by laboratory diagnostics by means of nucleic acid detection, e.B. PCR test, and must have been at least 28 days and a maximum of 6 months ago.
- **Proof of testing:** As proof of the absence of infection with the SARS-CoV-2, a test proof by the so-called "citizen tests" is considered (please find a list of official places below). This must be a maximum of 24 hours old. A test detection by means of nucleic acid detection, like the PCR test may not be more than 48 hours old. For students, proof of the student booklet issued by the school also applies. The test certificate must be available in analogue or digital form. The hotel employees, who are not vaccinated or recovered, have to participate in the hotel's internal test program twice a week.

The presence of one of these three preconditions will be checked by our staff at check-in at the reception.
